**ORDINANCE NO. 2013-019**

**AN ORDINANCE AMENDING THE  
VILLAGE OF VERNON HILLS CODE  
OF ORDINANCES, CHAPTER 11  
MECHANICAL VENDING MACHINES  
AND AMUSEMENT DEVICES;  
SECTION 11-32, PROPRIETARY  
LICENSE CLASSES AND  
LIMITATIONS; PARAGRAPH: (B)**

**WHEREAS**, the Village of Vernon Hills is a municipal corporation existing under the laws of the State of Illinois, and

**WHEREAS**, the Village, as a municipal corporation, has a duty to regulate coin-operated amusement device establishments which require a proprietary license; and

**WHEREAS**, the President and Board of Trustees hereby adopts this ordinance amending the Mechanical Vending Machines and Amusement Devises Ordinance of the Village of Vernon Hills pursuant to its duty to regulate the issuance of proprietary licenses within the Village of Vernon Hills.

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION I.** That Section 11-32, Proprietary License Classes and Limitations, paragraph (b) of the Code of Ordinances of the Village of Vernon Hills is hereby amended to read as follows:

- (1) "There shall be not more than two class A licenses, not more than ~~(two)~~ four class B licenses and not more than five class C licenses for each 15,000 of population."

**SECTION II. SEVERABILITY.** In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

**SECTION III. REPEAL AND SAVINGS CLAUSE.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

**SECTION IV. EFFECTIVE DATE.** This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

**SECTION V. PUBLICATION.** This ordinance shall be published in pamphlet for in the manner provided by law.

**SECTION VI. ORDINANCE NUMBER.** This ordinance shall be known as Ordinance Number 2013-019.




