

**RESOLUTION 2013-028**

**A RESOLUTION GRANTING APPROVAL TO OPERATE AN  
OUTDOOR SPECIAL EVENT FOR THE TILTED KILT  
LOCATED AT 447 NORTH MILWAUKEE AVENUE**

**WHEREAS**, the Tilted Kilt located at 447 North Milwaukee Avenue has submitted an Outdoor Establishment permit application and plan for authorization to operate an outdoor special event; and

**WHEREAS**, the property, as described herein is located within the B-1, General Business District; and

**WHEREAS**, Section 13.7.6 of the Zoning Code authorizes the Village Board to approve outdoor uses within the B-1 General Business District; and.

**WHEREAS**, the Board of Trustees, at their Committee of the Whole meeting on February 19, 2013 having reviewed and considered the request for an outdoor special event, found that the application and plan sufficiently comply with Section 13.7.6 of the Zoning Code and which, in its judgment, would justify recommending approval of the Outdoor special event.

**NOW, THEREFORE, BE IT RESOLVED** by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that the Village of Vernon Hills will allow The Tilted Kilt to operate an outdoor Special event, conditioned upon:

1. The special event will take place from Friday, March 15, 2013 through Sunday March 17, 2013.
2. Permitted hours of operation are Friday & Saturday 11:00 am to 2:00 am and Sunday, 11:00 am to 1:00 am.
3. Compliance with the site plan dated February 1, 2013.
4. Garbage receptacles shall be provided and the general vicinity shall be cleaned immediately following the event.
5. The service of alcohol shall be in accordance with Chapter 3 of the Vernon Hills Code of Ordinances.
6. A snow fence or equal alternative barrier shall remain around the perimeter for the entire duration of the event.
7. The Tilted Kilt is required to hire two (2) off duty Vernon Hills Police Officers to be on site during the "live entertainment" portion of the event. The Tilted Kilt shall be responsible for the cost of the officers at a rate determined by the Village.

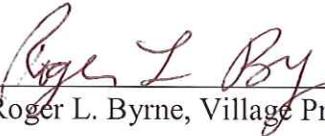

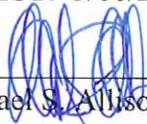
