**ORDINANCE NO. 2010-054**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE VILLAGE OF VERNON HILLS, CHAPTER 25, COMPREHENSIVE FEES AND PENALTIES**

**WHEREAS**, The President and Board of Trustees of the Village of Vernon Hills is authorized to prescribe minimum standards for the purpose of promoting the convenience and general welfare for the people of Vernon Hills; and

**WHEREAS**, The Village of Vernon Hills Police Department provides fingerprinting services to individuals who need a record of their fingerprints; and

**WHEREAS**, Changes in legislation requiring background checks in connection with the hiring of school and park district employees, combined with new hiring policies by private companies has significantly increased the number of individuals requesting to be fingerprinted; and

**WHEREAS**, the Board of Trustees having reviewed this matter at its COW meeting on September 8, 2010 has determined that it is necessary to assess reasonable fees to off-set the cost associated with providing fingerprinting services.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:**

**SECTION I.** That Chapter 25, Section 25-17 of the Village of Vernon Hills Code of Ordinances is hereby amended by adding a new fee, "Non-Resident Fingerprinting Services" to read as follows:

**Sec. 25-17. Police**

Non-Resident Fingerprinting Services	\$30
<u>Exception:</u> Employees of government agencies and not-for-profit organizations located in Vernon Hills shall be exempt.	

**SECTION II. SEVERABILITY.** In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of

its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

**SECTION III. REPEAL AND SAVINGS CLAUSE.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

**SECTION IV. EFFECTIVE DATE.** This ordinance shall be in full force and in effect from and after its passage, approval, and publication in pamphlet form as provided by law.


**SECTION V. ORDINANCE NUMBER.** This ordinance shall be known as Ordinance Number 2010-054




