**AN ORDINANCE REPEALING SECTION 10-16 –
REGULATION OF MOTION PICTURE
PRESENTATIONS, OTHER THEATRICAL
PRESENTATIONS**

WHEREAS, the President and Village Board have determined that there is not a need for notification to the Village Manager of certain motion picture presentations after midnight; and

WHEREAS, it has been further determined that there is not a need to regulate the hours of motion picture presentations.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

Section I. That Section 10-16 – Regulation of Motion Picture Presentations, Other Theatrical Presentations is hereby repealed.

Section II. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its severable applications, all-valid applications shall remain in effect.

Section III. REPEAL AND SAVINGS CLAUSE. All ordinance or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

Section IV. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval, and publication as provided by law.

Section V. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2009-037.






