

RESOLUTION 2016-039

**A RESOLUTION AUTHORIZING APPROVAL TO PARTICIPATE IN TWO JOINT BID CONTRACTS FOR THE PURCHASE OF 1600 TONS OF BULK ROAD SALT FOR THE 2016/2017 WINTER SEASON**

WHEREAS, the Public Works Department has budgeted \$112,000 for the purchase of bulk road salt in the FY2016-17 Street Maintenance Supplies account (0102053-530090); and

WHEREAS, participating in two separate joint bid contracts will allow the Village more flexibility and will hedge on purchasing costs; and

WHEREAS, based on previously recorded snow events and the Village's existing salt reserves, staff is comfortable with committing the Village to purchase a total of 1,600 tons of bulk road salt for the 2016/2017 Winter season; and

WHEREAS, the Village is committing to purchase 840 tons of salt under a second year contract renewal through the State of Illinois, Bureau of Strategic Sourcing and Procurement bid contract; and

WHEREAS, Lake County Purchasing will be soliciting bids for highway ice control (bulk road salt), and the Village is committing to participate, and purchase 760 tons of salt under the new Lake County Joint Bid Contract; and

WHEREAS, the Village of Vernon Hills will be under contractual obligation to purchase 80% of each of the State and County's committed purchase amounts, and the salt provider through the County contract is required to supply up to 100% of the committed purchase amount, and the State contract salt provider up to 120% of the committed purchase amount; and

WHEREAS, all purchases over \$20,000 require Board of Trustee approval.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, the Village Manager is authorized to commit the Village to participate in both the State of Illinois, Bureau of Strategic Sourcing and Procurement bid renewal contract; as well as the Lake County Purchasing Joint Bid for the purchase of 1,600 tons total of bulk rock salt during the 2016-17 winter season.




