

**RESOLUTION 2016-040**

**A RESOLUTION AUTHORIZING THE APPROVAL OF A CONTRACTOR AGREEMENT FOR THE 2016 ROAD REHABILITATION PROJECT WITH A LAMP CONCRETE CONTRACTORS, INC. IN AN AMOUNT NOT TO EXCEED \$569,925.98**

WHEREAS, the President and Board of Trustees desire to maintain the Village's infrastructure; and

WHEREAS, the President and Board of Trustees approved a budget of \$800,000 to cover the costs associated with the 2016 Road Rehabilitation Project within the FY2016-17 budget account (0309109-550050); and

WHEREAS, the 2016 road resurfacing work will be performed on the following streets:

New Century Town Manor Homes Subdivision: Brook Lane, Streamwood Lane, Bluewater Lane, Southwick Circle, Hemmingway Court, Clairmont Court, Coventry Circle, Wentworth Court, Sutton Court, Cromwell Court, Regency Court, and Regency Drive.

Also included are streets within the Woodbine Circle Subdivision within the limits of the Village on North and South Woodbine Circle; and

WHEREAS, the 2016 Road Rehabilitation Program plans were publicly bid and opened on March 8, 2016 with A Lamp Concrete Contractors, Inc., 1900 Wright Blvd., Schaumburg, IL 60193, submitting the lowest qualifying bid of \$569,925.98; and

WHEREAS, the additional \$230,074.02 budgeted will be available within account (0309109-550050) for any additional work found to be necessary or advantageous to the Village via a Resolution amendment.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, the Village Manager is authorized to execute a contract with A Lamp Concrete Contractors, Inc. for work to be completed under the 2016 Road Rehabilitation Project; and

THAT, the Finance Director is authorized to make payment to A Lamp Concrete Contractors, Inc. in an amount not to exceed \$569,925.28 for said work.




