ORDINANCE NO. 2016-036

**AN ORDINANCE AMENDING THE
VILLAGE OF VERNON HILLS, CODE
OF ORDINANCES, CHAPTER 3,
ALCOHOLIC LIQUOR CONTROL;
SECTION 3-12, LICENSE
CLASSIFICATION AND FEES;
PARAGRAPH: (1) CLASS "A" AND
PARAGRAPH: (5) CLASS "E" AND
PARAGRAPH: (12)(7) CLASS "L"**

WHEREAS, the Village of Vernon Hills is a municipal corporation existing under the laws of the State of Illinois, and

WHEREAS, the Village, as a municipal corporation, has a duty to regulate the purchase, sale and serving of alcoholic beverages to the public for the protection of the public, health, safety, morals and welfare; and

WHEREAS, the President and Board of Trustees hereby adopt this Ordinance amending the Liquor Control Ordinance of the Village of Vernon Hills pursuant to its duty to regulate the purchase and sale of alcoholic beverages within the Village of Vernon Hills.

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

SECTION I. That Section 3-12, paragraph (1) Class "A" license of Chapter 3 of Code of Ordinances of the Village of Vernon Hills is hereby amended to read as follows:

(1) Class "A" license: A class "A" liquor license shall authorize the retail sale of alcoholic liquors for consumption only on the premises specified. There shall not be issued at any one time any more than twenty-seven (27) class "A" liquor licenses in the village.

SECTION II. That Section 3-12, paragraph (5) Class "E" license of Chapter 3 of the Code of Ordinances of the Village of Vernon Hills is hereby amended to read as follows:

(5) Class "E" license: A class "E" liquor license shall authorize the retail sale of beer and wine for consumption only on the premises specified. There shall not be issued at any one time any more than nine (9) class "E" liquor licenses in the village.

SECTION III. That Section 3-12, paragraph (12)(7) Class "L" license of Chapter 3 of the Code of Ordinances of the Village of Vernon Hills is hereby amended to read as follows:

(12) Class "L" license: A class "L" license shall authorize the online sale of wine not for consumption on the premises. Class "L" licenses shall be subject to the following conditions and limitations.

7. Not more than zero (0) class "L" licenses shall be issued at any one time in the village.

SECTION IV. SEVERABILITY. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this Ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION V. REPEAL AND SAVINGS CLAUSE. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION VI. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION VII. PUBLICATION. This Ordinance shall be published in pamphlet for in the manner provided by law.

SECTION VIII. ORDINANCE NUMBER. This Ordinance shall be known as Ordinance Number 2016-036.


