

RESOLUTION 2016-134

A RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN THE VILLAGE OF VERNON HILLS AND THE POPCORN FACTORY INC TO ALLOW FOR TEMPORARY EMPLOYEE PARKING AT 730 LAKEVIEW PARKWAY IN VERNON HILLS

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, as part of the Five Year Capital Improvement Plan, the Village will be repaving the parking lot located outside of the Police Department at 754 Lakeview Parkway in Vernon Hills; and

WHEREAS, during the paving of the Parking Lot, the Village must locate alternative parking for Police Department employees and patrons; and

WHEREAS, The Popcorn Factory Inc. is currently operating at 730 Lakeview Parkway in Vernon Hills and has offered to allow alternative parking for employees and patrons in their parking lot during the repaving project; and

WHEREAS, the Village desires to contract with The Popcorn Factory Inc. to provide alternative parking during this repaving project.

NOW THEREFORE BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE: APPROVAL OF AGREEMENT. The Agreement between the Village and The Popcorn Factory Inc shall be, and it is hereby, approved in substantially the form attached to this Resolution as Exhibit A, and as approved by the Village's Corporation Counsel.

SECTION TWO: EXECUTION OF AGREEMENT. The Village Manager shall be, and is hereby, authorized and directed to execute and attest, on behalf of the Village, the agreement.

SECTION THREE: EFFECTIVE DATE. This Resolution shall be in full force and effect upon its passage and approval by a majority of the members of the Village Board.


