AN ORDINANCE AMENDING ORDINANCE NO. 2012-020 DESIGNATING STOP INTERSECTIONS AND YIELD INTERSECTIONS

Whereas, Chapter 11, Article III, Section 304, of the Illinois Compiled Statutes provides for the designation of stop intersections and yield intersections and for erection of stop signs or yield signs at one or more entrance thereto;

Whereas, the Corporate Authorities of this Village have determined that it is in the best interest of the residents of this Village and for the public health, safety and welfare thereof to control the access to roads and highways within the Village and in particular, at certain intersections as hereinafter designated:

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION I. That Section I of Ordinance Number 2012-020, be and hereby amended to read as follows:

SECTION II. DESIGNATION OF STOP INTERSECTIONS.

The intersections within the Village of Vernon Hills are hereby designated as stop intersections within the meaning of the Illinois Vehicle Code as shown on the attached database entitled Stop Intersections (newly designated in bold type*).

SECTION III. That Section II of Ordinance Number 2012-020, be and hereby amended to read as follows:

SECTION IV. DESIGNATION OF YIELD INTERSECTIONS. The intersections within the Village of Vernon Hills are hereby designated as yield intersections within the meaning of the Illinois Vehicle Code as shown on the attached database titled Stop/Yield Intersections (newly designated in bold type*).

SECTION V. SEVERABILITY. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION VI. REPEAL AND SAVINGS CLAUSE. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this Ordinance.


SECTION VII. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

SECTION VIII. PUBLICATION. This ordinance shall be published in pamphlet form in the manner provided by law.

SECTION IX. ORDINANCE NUMBER. This Ordinance shall be known as Ordinance Number 2016-042.
