

RESOLUTION 2012-164

A RESOLUTION WAIVING THE COMPETITIVE BIDDING PROCESS, AND AUTHORIZING THE VILLAGE BOARD TO ACCEPT PROPOSALS FOR SNOW AND ICE CONTROL SERVICES FROM ACRES GROUP, ASPEN LANDSCAPING, ARROW SHOP, BRICKMAN, VERNON TOWNSHIP, AND JAMES MARTIN AND ASSOCIATES FOR THE 2012/13 WINTER SEASON IN AN AMOUNT NOT TO EXCEED \$130,000

WHEREAS, the Village received proposals from Acres Group, Aspen Landscaping, Arrow Shop, Brickman, Vernon Township, and James Martin and Associates to provide snow and ice control services during the 2012/13 Winter season; and

WHEREAS, each of these contractors has been providing the Village with snow and ice control services since 2008/09, and are familiar with the scope of work; and

WHEREAS, the following is a cost comparison between the 2011/12 season, and the proposed 2012/13 season based upon the amount of snowfall per occurrence; and/or the accumulative snowfall for the entire season as described in each proposal; and

WHEREAS, all contracts will be for a one (1) year term except for James Martin and Associates, which is for three (3) years that began in 2011/12 and will terminate in 2013/2014 with a 1.5% increase per year; and

WHEREAS, the necessary funds are budgeted in FY 2012-13 street contractual services account 0102040-520630, and the Metra street contractual services account 0909085-520630 for the snow removal of streets, cul-de-sacs, and sidewalks.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, the Village Board waives the competitive bidding process and the Village Manager is authorized to sign contracts for snow and ice control services with Acres Group, Aspen Landscaping, Arrow Shop, Brickman, James Martin and Associates, and Vernon Township for the 2012/13 Winter season; and

THAT, the Finance Director is authorized to make payments to the above listed vendors in a total amount not to exceed \$130,000 for FY 2012/13.


