

**MINUTES OF THE  
VILLAGE OF VERNON HILLS

**2. VERNON HILLS PARK DISTRICT, 294 EVERGREEN DRIVE, REQUESTS A CLASS "G" LICENSE FOR RIBFEST & CRAFT BEER TASTING EVENTS**

Jeff Fougousse, Executive Director, Vernon Hills Park District, appeared before the Liquor Commission to request Class G liquor licenses for two events in 2016 - Little Bear Ribfest on August 19 and 20 at Century Park and Craft Beer Tasting on February 20 at Sullivan Center. The approval would allow only BASSET trained volunteers to sell and serve beer at the Craft Beer Tasting and beer and wine at Ribfest. They also request a wavier of fees.


