**AN ORDINANCE AMENDING THE
CODE OF ORDINANCES OF THE
VILLAGE OF VERNON HILLS,
CHAPTER 19, SECTION 19-3,
BUILDING MOUNTED SIGNS**

WHEREAS, the President and Board of Trustees of the Village of Vernon Hills is authorized to prescribe minimum standards for the purpose of promoting the convenience and general welfare for the people of Vernon Hills including the appropriate display of signs; and

WHEREAS, the Village Sign Code, section 19-3(c)(6)(a) prohibits the display of building mounted signs on office buildings; and

WHEREAS, the Village Sign Code, section 19-3(c)(7)(a) entitles office buildings to have building mounted Signs along public streets and access roads; and

WHEREAS, the two sections of the Sign Code referenced herein relating to building mounted signs on office building provide conflicting regulations; and

WHEREAS, the Board of Trustees having reviewed the conflict in the Sign Code at their Committee of the Whole meeting on February 21, 2012 determined that Section 19-3(c)(7)(a) allowing building mounted signs on office buildings is appropriate and that 19-3(c) (6) (a) should be deleted from the Sign Code to eliminate the conflicting provisions.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION I. That Chapter 19, Section 19-3(c)(6)(a), "Building Mounted Signs" be amended by deleting the exception, "Building mounted signs are prohibited on single and multi-tenant office buildings" in its entirety.

SECTION II. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION III. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing

herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION IV. EFFECTIVE DATE. This ordinance shall be in full force and in effect from and after its passage, approval, and publication in pamphlet form as provided by law.


SECTION V. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2012-016


