ORDINANCE NO. 2012-022

AN ORDINANCE GRANTING APPROVAL TO THE
OFFICIAL ZONING MAP FOR THE VILLAGE OF
VERNON HILLS, LAKE COUNTY, ILLINOIS

WHEREAS, the Village of Vernon Hills, pursuant to State Statutes, reviews the Official Zoning Map of the Village of Vernon Hills on an annual basis; and

WHEREAS, certain amendments were made to the Official Zoning Map during the previous twelve months due to annexation or other actions consistent with the required posting of due notice and after public hearings being held by the Planning and Zoning Commission of the Village of Vernon Hills, pursuant to the Vernon Hills Zoning Ordinance of 1982, as amended; and

WHEREAS, the Board of Trustees has previously taken action to approve said amendments to the Official Zoning Map during the previous twelve months.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION I. The Official Zoning Map of the Village of Vernon Hills is hereby approved. Said Map is attached in Exhibit A.

SECTION II. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION III. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION IV. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION V. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2012-022.




