ORDINANCE NO. 2012 - 029

AN ORDINANCE AUTHORIZING THE SALE OF CERTAIN PERSONAL PROPERTY OWNED BY THE VILLAGE

WHEREAS, the Village is a home rule municipal corporation organized and existing under the Constitution of the State of Illinois and Statutes of the State of Illinois and empowered by statutes; and

WHEREAS, in the opinion of the corporate authorities of the Village of Vernon Hills, it is no longer necessary or useful to or for the best interests of the Village to retain a John Deere fairway mower (Model 3215B S/N TC3215B030072) now owned by it; and

WHEREAS, the fairway mower has been put up for auction on more than one occasion; and

WHEREAS, the Village has not been successful in its efforts to sell the fairway mower at auction; and

WHEREAS, the Village now has a potential buyer for the fairway mower that has offered to pay for the fairway mower;

WHEREAS, the Village Board of Trustees deem it appropriate to sell the fairway mower as it has not been useful to the Village for some time.

THEREFORE, BE IT ORDAINED, by the President and Village Board of Trustees of the Village of Vernon Hills, Illinois, as follows:

SECTION 1: The foregoing recitals are incorporated herein as findings of the Corporate Authorities.

SECTION 2: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4) the Corporate Authorities find that the sale of the fairway mower, now owned by the Village, is no longer necessary or useful to the Village and it is in the best interest of the Village to sell this equipment.

SECTION 3: Pursuant to said Section 11-76-4, the Village Manager be and is hereby authorized and directed to sell the John Deere Fairway Mower to the Golf Club of Aberdeen for the sum of \$3,500.


SECTION 4: This Ordinance shall be in full force and effect from and after its adoption as provided by law.




