**AN ORDINANCE GRANTING APPROVAL OF
TEMPORARY LEASING TRAILERS FOR
NORTHSHORE UNIVERSITY HEALTH SYSTEM
LOCATED AT 225 NORTH MILWAUKEE AVENUE,
VILLAGE OF VERNON HILLS LAKE COUNTY.**

WHEREAS, NorthShore University Heal System has petitioned the Village of Vernon Hills for approval of temporary CT and MRI trailers at 225 North Milwaukee Avenue; and

WHEREAS, the Vernon Hills Code of Ordinances requires owners to seek approval from the Board of Trustees prior to amending a site plan; and

WHEREAS, the Board of Trustees, having reviewed and considered the temporary trailers at the Committee of the Whole meeting on January 5, 2010, found that the design and location of the trailer sufficiently complies with the requirements and standards of Chapter 16, Article IV of the Villages' Code of Ordinances and which, in its judgment, would justify it in recommending approval of the revised site plan:

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION I. Pursuant to the Vernon Hills Code of Ordinances, as amended, the site plan revisions to allow temporary CT and MRI trailers for NorthShore University Health System, 225 North Milwaukee Avenue is hereby approved subject to the following conditions:

1. Compliance with the proposed site plan prepared by OKW Architects, dated October 28 , 2009
2. Compliance with the plan layout and elevation drawings prepared by AK Specialty Vehicles, dated October 28, 2009
3. The trailer and all appendices shall be removed from the site no later than September 30, 2010.

SECTION II. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.


SECTION III. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION IV. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION V. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2010-008.




