AN ORDINANCE AMENDING ORDINANCE  
NOS. 2006-48, 2005-34, 2005-24, 2004-21, 2002-47,

ESTABLISHING SPEED LIMITS ON HIGHWAYS  
AND STREETS WITHIN THE CORPORATE  
LIMITS OF THE VILLAGE OF VERNON HILLS,  
LAKE COUNTY, ILLINOIS.

WHEREAS, the basic statutory vehicular speed limits established by Section 11-601 of the Illinois Vehicle Code are greater than that considered reasonable and proper on the streets in the Village of Vernon Hills for which the Village has maintenance responsibility and which is not under the jurisdiction of the County of Lake or the Illinois Department of Transportation; and

WHEREAS, the Village Board of the Village of Vernon Hills has caused to be made an engineering and traffic investigation upon Village streets; and

WHEREAS, the Chapter 625, Act 11, Article VI, Section 11-604 of the Illinois Compiled Statutes permits the alteration of speed limits by local authorities upon completion of said engineering and traffic investigation; and

WHEREAS, the Corporate authorities have determined that it is in the best interest of the health, safety, and welfare of its residents to make the following alteration to Village speed limits.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION I. MAXIMUM SPEED.** It shall be unlawful for any person to operate, control or maintain any vehicle, motor propelled or self propelled, upon the highways or streets of the Village of Vernon Hills within its corporate limits at more than 30 miles per hour excepting only as herein otherwise provided for in Sections III and IV of this ordinance.

**SECTION II.** That Section II of Ordinance Number 2009-018, be and it is hereby amended to read as follows:

**SECTION II. DESIGNATION OF STREETS WITH A 30 MILE PER HOUR SPEED LIMIT.** The streets within the Village of Vernon Hills shall have a speed limit of 30 miles per hour as shown on the attached database entitled Speed Limits (newly designated in **bold**).

**SECTION III.** That Section III of Ordinance Number 2009-018, be and it is hereby amended to read as follows:

**SECTION III. DESIGNATION OF STREETS WITH A SPEED LIMIT OF 35 MILES PER HOUR.** The streets within the Village of Vernon Hills shall have a speed limit of 35 miles per hour as shown on the attached database entitled Speed Limits (newly designated in **bold**).

**SECTION IV. STREETS OR HIGHWAYS CONTROLLED BY OTHER GOVERNMENTAL AUTHORITY.** The provisions of this ordinance shall not apply to highways, streets, or roads within the

corporate limits of the Village of Vernon Hills, which are under the jurisdiction of the Illinois Department of Transportation or County of Lake.

**SECTION V. POSTING SIGNS.** Appropriate signs shall be posted upon all roads, highways, or streets subject to the jurisdiction of the Village as described in this ordinance, which shall declare the maximum speeds as hereinabove provided.

**SECTION VI. PENALTY.** Any person who shall violate any of the provisions of this ordinance shall be guilty of an offense hereunder and upon conviction thereof shall be punished by fine of not less than \$5.00 nor more than \$500.00 for each such violation.

**SECTION VII. SEVERABILITY.** In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

**SECTION VIII. REPEAL AND SAVINGS CLAUSE.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

**SECTION IX. EFFECTIVE DATE.** This ordinance shall be in full force and effect from and after its passage, approval, and publication as provided by law.

**SECTION X. PUBLICATION.** This ordinance shall be published in pamphlet form in the manner provided by law.


**SECTION XI. ORDINANCE NUMBER.** This ordinance shall be known as Ordinance Number 2009-018


