ORDINANCE NO. 2009-035

**AN ORDINANCE CHANGING THE STREET
NAME OF NORTH SOUTH ROAD TO BYRNE
BOULEVARD WITHIN THE VILLAGE OF
VERNON HILLS AND PROVIDING FOR
NOTIFICATION OF SAME.**

WHEREAS, President Byrne was instrumental in the "taking of Half Day;" and

WHEREAS, on July 7, 2009 the Committee of the Whole met and agreed changing of said street name would be in the best interest of the Village; and

WHEREAS, Roger Byrne has been Village President since 1993 and Trustee from 1987 to 1993; and

WHEREAS, President Byrne has been instrumental in developing Port Clinton Place, the Village's first TIF District; and

WHEREAS, the Corporate Authorities have determined that North South Road name should be changed to Byrne Boulevard.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNT, ILLINOIS, AS FOLLOWS:

SECTION 1. *Change of Street Name.*

The following designated present name of this street, roadway or other public ways within the Village of Vernon Hills shall be and are hereby changed and amended to that name designated as are hereinafter set opposite the present name thereof and by which new the new name and designated such street and roadway shall be henceforth known.

Present Name
North South Road

New Name
Byrne Boulevard

SECTION 2. *Notification.*

The Village Clerk shall notify the election authority of the jurisdiction within the Village and the Post Office branch servicing the Village of such change in name in writing by certified or registered mail including the Fire District.

SECTION 3. *Effective Date.*

The change of name of said street or public ways should be effective thirty (30) days after the giving of the aforesaid notification by the Village Clerk as in Section 2 provided.

SECTION 4. *Ordinance Number.*

This Ordinance shall be known as Ordinance No. 2009-035.

SECTION 5. *Repealer.*

All ordinances or parts of ordinances in conflict herewith are hereby repealed but except as so repealed, all ordinances shall be and remain in full force and effect.

SECTION 6. *Effective Date of ordinance.*

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.




