WHEREAS, Roundy's Supermarket, Inc., has petitioned the Village of Vernon Hills for approval to amend ordinance 2003-044 as amended by Ordinance 2011-019 granting an extension for the temporary use of a trailer at 512 Gregg's parkway for use as a hiring facility; and

WHEREAS, The development agreement approving the PUD for Gregg's Landing authorizes the Board of Trustees to approve the temporary use of the trailer without a hearing before the Planning and Zoning Commission; and

WHEREAS, the Board of Trustees, at its meeting on April 6, 2011, granted approval allowing temporary use of the trailer at 512 Gregg's Parkway for use as a hiring facility in connection with Mariano's. Temporary use of the trailer was granted until July 1, 2011.

WHEREAS, Roundy's Supermarket, Inc., is requesting temporary use of the trailer be extended until August 31, 2011.

WHEREAS, The Board of Trustees, having reviewed and considered the request to extend the temporary use at their meeting on June 21, 2011 found that allowing the temporary use of the trailer as a hiring facility sufficiently complies with the development agreement approving the PUD and which, in its judgment, would justify it in recommending approval:

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION I. Pursuant to the Code of Ordinances, as amended and the development agreement approving the PUD for Gregg's, authorization to allow temporary use of the trailer as a hiring facility is hereby approved subject to the following conditions:

1. The trailer would be used to perform employee interviews and hiring for Roundy's Supermarket, Inc employees. Applicants are required to apply on-line and not on site.
2. A maximum of four employees are permitted on location at any one time.
3. Use of the trailer as a hiring facility is permitted from July 1, 2011 to August 31, 2011.
4. Permitted hours of operation are from 7:00 AM to 8:00 PM Monday – Saturday.

5. Employees are required to park in a designated area of the Roundy's Supermarket, Inc (Mariano's) parking lot.

SECTION II. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION III. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION IV. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION V. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2011-036


