ORDINANCE NO. 2011 - 047

AN ORDINANCE ACKNOWLEDGING THE AUTHORITY UNDER WHICH THE VILLAGE HOME RULE HOTEL OR MOTEL OCCUPANCY TAX IS ADOPTED IN THE VILLAGE OF VERNON HILLS

WHEREAS, the Village of Vernon Hills is a municipal corporation organized and existing under the Statutes of the State of Illinois and empowered by statutes; and

WHEREAS, the Village gained home rule status as a result of the recent decennial census in 2010; and

WHEREAS, the Village initially adopted its hotel or motel occupancy tax pursuant to the Illinois Municipal Code; and

WHEREAS, now that the Village has achieved home rule status, the Village desires to ratify and re-adopt its hotel or motel occupancy tax pursuant to the Village's home rule authority and expand the available uses to which the tax may be put.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION I: The Village Board of Trustees hereby ratifies and re-adopts its hotel or motel occupancy tax pursuant to the Village's home rule authority.

SECTION II: The Village hereby amends Section 21-144 (b) of its Hotel or Motel Occupancy tax by deleting it in its entirety and replacing it with the following:

(b) The amounts collected by the village pursuant to this Section shall be expended for any and all purposes deemed appropriate by the Corporate Authorities of the Village.

SECTION III: This Ordinance shall be in full force and effect from and after its adoption as provided by law.


SECTION IV. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2011-047.




