ORDINANCE 2016-026

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE VILLAGE OF VERNON HILLS, CHAPTER 25, SECTION 25-12, ADOPTING BY REFERENCE OF THE VERNON HILLS ATHLETIC COMPLEX FIELD USE AND USER FEE POLICY

WHEREAS, the Vernon Hills Athletic Complex located at 311 Nike Parkway Vernon Hills, IL is owned by the Village of Vernon Hills and consists of athletic fields available for use by organizations both public and private; and

WHEREAS, the Village of Vernon Hills is responsible for the maintenance of the facility and has employed staff to perform maintenance and repairs; and

WHEREAS, a policy is necessary to outline rules and regulations pertaining to the use of the fields; and

WHEREAS, the policy shall allow for user fees to be collected from organizations to help offset a portion of the cost of the maintenance of the facility; and

WHEREAS, the Committee of the Whole having met on July 19, 2016 discussed and directed staff to prepare an Ordinance regarding the proposed Vernon Hills Athletic Complex Field Use and User Fee Policy; and

WHEREAS, user fees may be waived for some users in exchange for mutual considerations; and

WHEREAS, the user fees require codification in Chapter 25, Section 25-12 of the Vernon Hills Code of Ordinances to reflect said fees consistent with the Vernon Hills Athletic Complex Field Use and User Fee Policy.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS AS FOLLOWS:

SECTION I: That there is hereby adopted by reference, as if fully set out herein, that certain policy known as VERNON HILLS ATHLETIC COMPLEX FIELD USE AND USER FEE POLICY.

SECTION II: Amend Chapter 25 of the Vernon Hills Code of Ordinances, amending Section 25-12 by addition of the following fee table for VHAC User Fees.

Lacrosse	\$10 per player
Adult Softball/Kickball ¹	\$10 per player
Sports Camps and Clinics ¹	\$10 per participant

Soccer Tournaments	\$15 per game
Other Events- Resident	\$40 per hour, per field
Other Events- Non Resident	\$75 per hour, per field
Field Lighting (see below)	\$40 per hour

¹ Vernon Hills Park District (VHPD) run program player fees are waived by agreement

SECTION III: That in the event that the rules, regulations, terms or conditions imposed pursuant to the VERNON HILLS ATHLETIC COMPLEX FIELD USE AND USER FEE POLICY are either more restrictive or less restrictive than comparable rules, regulations, terms or conditions imposed by any other applicable rule, regulation, resolution, ordinance, statute or law, then the most restrictive rules, regulations, terms or conditions shall govern.

SECTION IV: That all ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, expressly repealed.

SECTION V: That this Ordinance shall be in full force and effect ten (10) days after its passage, approval and publication in pamphlet form, as provided by law.


SECTION VI: This Ordinance shall be known as Ordinance Number 2016-026.






